Membership Education: More than 150 LIONs participated in peer-led learning groups, culminating in an in-person session at the 2025 Summit. Across the network, the LION community continued to provide a trusted space for publishers to exchange ideas, challenges, and resources during a difficult year for many newsrooms. Year round, LION members and other industry colleagues make up the community of 1600+ members in the News Entrepreneur Community Slack. Participants have focused discussion spaces for peer learning and specific LION programs, as well as place-based and other channels that any member of the Slack can contribute to.

Data & Evaluation: We launched the self-serve Audit, transforming a cohort-based, highly customized program into a scalable product available to any LION member at any time. In its first six months, members completed 402 Audits, nearly matching the 450 completed over the program's previous three-year history.

Explanation**Membership Services & LION Awards:**

We completed the successful Sustainability 360 pilot and launched our first full S360 cohort, providing members with hands-on back-office support and strategic coaching. In parallel, we piloted a new Back Office support program focused on helping early-stage members build strong HR and finance foundations for long-term sustainability. We partnered with Press Forward on a new program that offers Audits and strategic business coaching to the 205 news outlets awarded Closing Local Coverage Gaps grants in 2024. This marks the first time in LION history that a program serves more non members than members. We also launched the members-only LION Growth Grant program, reviewing over 220+ applications from members in 48 states, and distributing \$750K of a planned total \$1.5M to 15 publishers for operational funds to strengthen their business operations. Finally, we piloted and expanded direct consulting services in our Back Office and Sustainability 360 programs, which both included consulting hours with HR and/or Finance experts to provide publishers with hands-on support for strengthening their operations.
